Horses must be vaccinated according the FEI Guidelines, immune to influenza (6 month interval) and also be free from contagious diseases. Liability insurance must be in place for every horse and rider.

Horses which were in contact with EHV1 within a 6 weeks timeframe before the show are not allowed to participate. This includes being on a horse show or in a barn together with EHV1 infected horses.

The equine passport with active immunization must be shown voluntarily at the show office before the show.

I agree with the above terms and conditions and will follow the instructions and rules issued by the Show producer and manager. I accept the rules of the respective rule books.
