General information

An equine passport with active vaccination protection must be presented for all horses brought to the show - including helpers' horses. Vaccination Influenza vaccination interval of 9 months is mandatory, herpes vaccination is requested. By submitting the entry form, the participant bindingly declares that he has read and taken note of the entire entry form, that the named horse is free of infectious diseases and comes from an and comes from a disease-free herd, that he will bear the costs of the veterinary examination in the event of symptoms of illness and that the horse and rider are covered by liability insurance.

We would like to point out that since January 1, 2005, both competition riders and leisure riders have been obliged to take out riders to carry a current EU health certificate with them when crossing the border into another EU country. This must be issued by the veterinarian of the stable responsible for the horse

Participation or attendance at this event is at your own risk. The organizer assumes no liability for Damage of any kind. The riders or owners are liable for damage caused by their animals to the organizer's facilities and/or third parties cause. It exists between the organizer on the one hand and the visitors, horse owners, owners and on the other hand, there is no contractual relationship with tournament participants; in particular, participants are not assistants within the meaning of Sections 278 et seq. and 831 BGB.
